Guest Lecturer Professor Dame Carol Black Thursday 7 April 14.45

Professor Dame Carol Black is currently Chair of the British Library, the Centre for Ageing Better, and Think Ahead, the Government's fast-stream training programme for Mental Health Social Workers. She chairs NHS England/Improvement's Advisory Board on Employee Health and Wellbeing, and is Adviser to NHSI and PHE on Health and Work. She is also a member of RAND Europe's Council of Advisers, and of the Boards of the Institute for Employment Studies and UKActive.

In 2019 she completed a seven-year term as Principal of Newnham College Cambridge, where she was a Deputy Vice-Chancellor. She still sits on the University's Strategy Board on Student Mental Health and Wellbeing. She is a Patron of the Women's Leadership Centre in the Judge Business School.

Although testosterone levels progressively fall with ageing, mainly due to suppression of gonadotropin secretion with co-morbidities, the vast majority of older men retain Leydig cell responsiveness to gonadotropin stimulation.

However, a small percentage of older men exhibit profound Leydig cell dysfunction, with low testosterone and markedly raised LH & FSH levels (Primary Testicular Insufficiency - PTI). These men unquestionably benefit from testosterone replacement as per any other hormone deficiency.

Where are these men and how do we identify them?
Although issues of sexual function predominate among young and middle-aged hypogonadal men, this may no longer be an issue for older men and their partners, so their presentation is likely to be very different.

Sex hormones play a major role in achieving and maintaining bone nealth during normal reproductive life, but testosterone also has an additional role in stimulating erythropoiesis. Populations of older men having "anaemia of unknown cause" or "age-related osteoporosis" are likely to be powerfully enriched with individuals having PTI, with the combination of both anaemia and osteoporosis being a reliable wallpaper-match for undiagnosed/untreated hypogonadism.

Experience from medical inpatients in Newcastle-upon-Tyne Hospitals suggests a 50% prevalence of PTI among older men with otherwise unexplained anaemia, such that the average Consultant could expect to make a diagnosis of PTI on ward rounds once or twice each week.
